The Grant County Fiscal Court met in regular session on Tuesday February 16, 2021 at 6:30pm via ZOOM in Williamstown, Kentucky. Those in attendance include the Honorable Judge/ Executive Chuck Dills, Magistrates Shawna Coldiron, Roger Humphrey and Jacquelyn Riley, Stephen Bates II, County Attorney, Colton Simpson, Deputy Judge/Executive, and Cherish Kennedy, Fiscal Court Clerk. Also joining via zoom was David Rose and Debby Lucas Angel.


Motion was made by Magistrate Humphrey and second by Magistrate Coldiron to approve the minutes of February 2, 2021. All in favor, motion carried.

Motion was made by Magistrate Coldiron and second by Magistrate Riley to approve all claims drawn in the general fund, road fund and jail fund along with all transfers presented dated February 16, 2021. All in favor, motion carried.
