Regular Meeting Minutes  
May 18, 2021  
6:30 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, May 18, 2021 at 6:30 P.M. in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Roger Humphrey, Magistrate Jacquelyn Riley, Magistrate Shawna Coldiron, County Attorney Steven Bates, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Cherish Kennedy. Also joining was David Rose, Tony Ashcraft, Melissa Moss, Peggy Updike, Steve Tatum, Brian Maines, Mike Webster, and Greg Brockman.

Invocation was led by Colton Simpson Deputy Judge/Executive and the Pledge of Allegiance was led by Judge/Executive Chuck Dills.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve the minutes of May 4, 2021. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve all claims drawn in the general fund, road fund, and jail fund along with all transfers presented dated May 18, 2021. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve the Dry Ridge EMS Local Agreement. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to declare a Green 1992 GMC M988 Humvee as surplus to the Williamstown Fire Department. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve Amanda Smith as the Building Inspector Administrative Assistant at a salary of \$30,000 annually, to be effective May 24, 2021. All in favor, motion carried.

Judge/Executive Chuck Dills honored and recognized our retirees, Diane Smith for her 20 years of service, Deputy Sheriff Kevin Burke for 15 years of service, and Deborah (Debbie) Vannarsdall for 27 years of service.

Reports were presented from Judge/Executive Chuck Dills. These reports are for review only and no action is required.

Judge/Executive Chuck Dills asked the audience if they wished to address the court. Greg Brockman thanked everyone for all their help with the EMS agreement, and David Rose requested a copy.
