Regular Meeting Minutes
September 6, 2023 @ 4:30 P.M.

The Grant County Fiscal Court met in regular session on Wednesday, September 6, 2023, at 4:30 P.M. at the Courthouse in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacquelyn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey, Judge Stephen Bates in place of County Attorney Stephen L. Bates II, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Jenna Johnson. Guest Sheriff Brian Maines and David Rose.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the special meeting minutes of August 22, 2023 and special meeting minutes of August 29, 2023. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve all claims on the general fund, road fund, jail fund, and ARPA fund along with all transfers presented dated September 06, 2023. All in favor, motion carried.



Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve the Surplus on County Property, see Attachment A, B and C to be sold at Public Auction on September 30, 2023 at 10.00 A.M at the Grant County Road Department. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve the claim to purchase a tract of property on KY HWY 330 Corinth, KY with the Corinth Volunteer Fire Department from Owen Electric Cooperative, Inc. and approval for Judge/Executive to execute the deed of conveyance on behalf of Grant County and any and all incidental documents related to the transfer of this property. All in favor, motion carried.

Reports were presented from Treasurer, Animal Shelter, Road Supervisor, Building Inspector, Coroner, Jailer, Sheriff, Judge/Executive Chuck Dills, Magistrate Riley, Magistrate Coldiron, and Magistrate Humphrey. These reports are for review only and no action is required.
