

Grant County Fiscal Court Regular Meeting Minutes April 16, 2024 @ 4:30 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, April 16, 2024, at 4:30 P.M. on zoom via video conference in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacqalynn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey, County Attorney Stephen Bates II, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Jenna Johnson. Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve the regular meeting minutes of April 02, 2024. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve all claims on the general fund, road fund, and jail fund along with all transfers presented dated April 16, 2024. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve the Surplus from the County Clerk's Office, see attachment A in the packet from the agenda. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve the recommendations of the bid committee for Grant County Road Department Materials and Supplies for Fiscal Year 2024-2025. This being awarded to Kim Crupper for Stone and Salt, Riegler Blacktop for Asphalt- Hot Mix, and World Fuel Services/Lykins Energy Solutions for daily pricing on Gasoline and Diesel. Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the recommendations of the bid committee for Grant County Fiscal Court Cleaning Services. This being awarded to Sunny Day Cleaning Solutions LLC for \$5,500/month. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve Resolution 2024-04, Interlocal Agreement between Grant County, Pendleton County, Grant County 109 Board, and Grant County Tire Processing. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve Resolution 2024-04, Interlocal Agreement between Grant County, Harrison County, Grant County 109 Board, and Grant County Tire Processing. All in favor, motion carried.
