Regular Meeting Minutes
June 18, 2024 @ 4:30 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, June 18, 2024, at 4:30 P.M. at the courthouse in Williamstown, Kentucky. Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve the regular meeting minutes of June 04, 2024. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve all claims on the general fund, road fund, and jail fund along with all transfers presented dated June 18, 2024. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to accept Grant County Local Board of Health Tax Rate for Year 2024. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to accept Grant County Sheriff's 2023 Tax Settlement, prepared by Monnie Leap. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve Resolution 2024-05, Adopting NKADD Title VI Policy and Procedures. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve Resolution 2024-06, Adopting the Emergency Action Plan and Fire Prevention Plan. All in favor, motion carried.

First Reading on Ordinance No. 0006-2024-0273, Craig Pennington Zone A1 to RA1 on Cason Lane. No action required.

First Reading on Ordinance No. 0007-2024-0274, John Perry and Missy Colson on Dry Ridge Mt. Zion Road. No action required.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve the Second Reading on Ordinance No. 0005-2024-0272, Amending Court Fees. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve the Second Reading on Ordinance No. 0004-2024-0271, Amending Occupational Tax. All in favor, motion carried.

Judge/Executive Chuck Dills asked the audience if they wished to address the court. Various people within the audience had questions regarding the amended ordinance (no. 0004-2024-0271), such as; How long will this last? Is there or will there be a cap? Is there a tax for travelers (transient room tax)? There were also questions/concerns regarding the Fiscal Court budget, county spendings, changing Fiscal Court meeting times, and voting.
