Regular Meeting Minutes

The Grant County Fiscal Court met in regular session on Tuesday, June 04, 2024, at 4:30 P.M. at the Courthouse in Williamstown, Kentucky. Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to accept the State Road Projects and FLEX Funds. All in favor, motion carried.

First Reading on Amending Ordinance No. 0005-2024-0272, Court Fees was presented. No action required.

Premiums, Payments to Election Officers, Election Commissioners, County Clerk Storage Fees and Training Meals- FY 2024-2025. All in favor, motion carried.
