Regular Meeting Minutes
October 01, 2024 @ 6:00 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, October 01, 2024, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the regular meeting minutes of September 16, 2024 and special meeting minutes of September 20, 2024. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve all claims on the general fund, road fund, and jail fund along with all transfers presented dated October 01, 2024. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve the Second Reading on Ordinance No. 0011-2024-0278, Amending the Special Ambulance Taxing District. Roll Call was made to secure a vote from each Fiscal Court member and all four AYED. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to appoint Chad Bedard to the Grant County Special Ambulance Taxing District Board, said term to begin October 1, 2024 and to expire on September 30, 2026. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to appoint Ashley Brinker to the Grant County Special Ambulance Taxing District Board, said term to begin October 1, 2024 and to expire on September 30, 2026. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the Road Safety Assessment Plan for Lemon Northcutt Road and Sherman Newtown Rd. All in favor, motion carried.

Domestic Violence Awareness Month Proclamation 2024 was presented. No action required.
