



Grant County Fiscal Court
Regular Meeting Minutes
April 01, 2025 @ 6:00 P.M.

The Grant County Fiscal Court met in regular session on Tuesday, April 01, 2025, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacqalynn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey via Zoom, Assistant County Attorney Pete Whaley, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Jenna Johnson. Guest Josh Brearton, Tonya Beagle, David Rose, Tony Morgan, Jim Bialik, Debby Lucas Angel, and Dennis Switzer.

Motion was made by Magistrate Coldiron and seconded by Magistrate Humphrey to approve the regular meeting minutes of March 18, 2025. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to approve all claims on the general fund, road fund, and jail fund, along with all transfers presented dated April 01, 2025. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to approve the revisions made to the Grant County Detention Center's Policy and Procedures Manual, per 501 KAR 3:020 Section 1. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve the advertisement for replacement of bridges for bid- Fords Mill Road, Clarks Creek Road, and Dry Ridge Mt. Zion. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Riley to approve Resolution 2025-02, to appoint Magistrate Shawna Coldiron, Grant County Special Ambulance Taxing District, to serve as an Ex Officio Non-Voting member, effective April 1, 2025 per KRS 65.009. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to appoint Rodney Smith of the Grant County Special Ambulance Taxing District to fill a vacancy, effective April 01, 2025 and to expire September 30, 2025. All in favor, motion carried

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to accept the applicants withdraw on the Second Reading on Ordinance No. 0002-2025-0285 United Skilled Services Zone Change (**applicant requested to withdraw**). All in favor, motion carried

New Business was presented with two proclamations, first one being Fair Housing Month 2025, and the second being Arbor Day 2025.

Judge/Executive Chuck Dills asked the audience if they wished to address the court, and there being none, a motion was made by Magistrate Riley and seconded by Magistrate Coldiron to adjourn.
