

The Grant County Fiscal Court met in regular session on Tuesday, May 06, 2025, at 6:00 P.M. at the courthouse in Williamstown, Kentucky. Those in attendance include the Honorable Judge/Executive Chuck Dills, Magistrate Jacqalynn Riley, Magistrate Shawna Coldiron, Magistrate Roger Humphrey, Assistant County Attorney Pete Whaley, Deputy Judge/Executive Colton Simpson, and Fiscal Court Clerk Jenna Johnson. Guest Joe Gordon, Dennis Switzer, Jerry Keith, David Rose, Debby Lucas Angel, and Jason Coffelt.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to approve the regular meeting minutes of April 15, 2025 and special meeting minutes of April 29, 2025. All in favor, motion carried.

Motion was made by Magistrate Coldiron and seconded by Magistrate Riley to approve all claims on the general fund, road fund, jail fund, and forestry fund along with all transfers presented dated May 06, 2025. All in favor, motion carried.

Motion was made by Magistrate Humphrey and seconded by Magistrate Coldiron to accept the recommendations of the bid committee for Grant County Road Department Three Bridge for Bid for Fiscal Year 2025-2026 (pending the final approval per the State). All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Coldiron to accept Kim Crupper of Crupper Transport for the Stone (see bid sheet for specs) bid. All in favor, motion carried.

Motion was made by Magistrate Riley and seconded by Magistrate Humphrey to accept Riegler Asphalt for the Hot Mix Base (\$75.00/ton) and Hot Mix Surface (\$82.00/ton) bid. All in favor, motion carried.
